An associate-cluster project funded by DG-ECHO concerning UAV use in SaR and civil protection tasks as an extension of community policing joined the event.

The stakeholders, attending the conference, will have the opportunity to interact with the projects' groups in order to identify organizational and technology challenges and capabilities as well as to assess the usefulness of the demonstrated solutions.

Keynote Speakers



Andrea De Candido – European Commission (EC), works for the Directorate General for Migration and Home Affairs of the EC where he has been recently appointed as the Deputy Head of the Unit dealing with Industrial Policy and Security Research. Among the responsibilities of the Unit is the production of the Secure Societies part of the European Union Research & innovation Framework Programme that enables cross border funding of research projects in the security dimension.



Thorsten Stodiek – Organization for Security and Cooperation in Europe (OSCE), Before assuming the position of Deputy Head of the Strategic Police Matters Unit in 2016, he served as the Unit's Adviser on Research and Analysis for eight years responsible for gathering, analyzing and reporting on all kinds of law enforcement-related information in the OSCE. This included, inter alia, the development of policy papers on the strategic development of OSCE's police-related activities, operational guideline documents on democratic policing practices and criminal justice system reform, and assessment reports on law enforcement development programmes of OSCE field operations.



Caroline Goemans-Dorny – INTERPOL, took office as the INTERPOL Data Protection Officer (IDPO) since January 2016. Her mandate includes amongst others monitoring compliance of data processing activities within INTERPOL, liaising with the Commission for the Control of INTERPOL's files (CCF), INTERPOL's external oversight body, and coordinating the work of the Data Protection Officers designated within the National Central Bureaus, established in each of the 190 member countries.



Sónia Sousa Pereira – EUROPOL, is currently working on the Data Protection Function of Europol dealing mostly with the handling of operational personal data. Sónia joined the Portuguese Data Protection Authority (DPA) as an independent consultant, dealing with the DPA Opinions on draft legislation, strategic and political advice to the Commissioners, drafting the Guidelines of the DPA on whistleblowing schemes, recording of phone calls in the employment context, drugs and alcohol use records, among others.



Leonard Doyle – International Organization for Migraton (IOM), is the Head of Media and Communications for the UN Migration Agency (IOM). He previously worked with IOM in Haiti and the Philippines in humanitarian emergencies. Prior to that he was a journalist and was US correspondent and Foreign Editor of The Independent (UK). He has also worked as an editor for The Observer and The Guardian newspapers. Leonard has been a foreign correspondent in New York, Washington DC and Brussels and had reported from Asia, Africa, Europe and the Americas.



Katrjin Hoedemakers – European CRIME Prevention Network (EUCPN), is the spokeswoman and communication officer of EUCPN. She graduated with honors from the University of Ghent with a Master's degree in European Studies, previously she studied Journalism at the Artevelde University College in Ghent. Before Before Katrijn joined EUCPN in 2017, she had been engaged by the Publications Office of the European Union, the Belgian Federal Public Service Foreign Affairs and Wolters Kluwer.



Ryan Prox – **Vancouver Police Department (VPD)**, is in Charge of the Crime Analytics Advisory & Development Unit that pioneers and implements analytic programs and technology for the VPD. He has developed a critical infrastructure analysis system for the province of British Columbia and oversaw the VPD's analytic contribution to the 2010 Vancouver Winter Olympics. Ryan is an Adjunct Professor at Simon Fraser University, Criminology Department, where he instructs on intelligence analysis.
